



Release and Waiver of Liability and Indemnity Agreement to the RTP Off Road Club

In consideration of being permitted to participate in any event sponsored, promoted, or directed by the RTP Off Road Club (herein known as ROC) the undersigned, his/her executors, administrators, personal representatives, heirs, and assigns hereby releases and forever discharges ROC, and ROC's officers, directors, promoters, sponsors, employees, and agents from any and all claims of loss or damage including personal injury or death whether or not caused by the negligent act or omission of ROC and/or ROC's officers, directors, promoters, sponsors, employees, and agents while the undersigned is for any purpose participating in an event sponsored, promoted, or directed by ROC.

It is fully understood by each of the undersigned that there is some inherent risk associated with this and subsequent events, including damage to vehicles.

IN ADDITION, the undersigned AGREES TO INDEMNIFY AND HOLD HARMLESS ROC, and ROC's officers, directors, promoters, sponsors, employees, and agents from any loss, liability damage, or cost they incur due to such participation by the undersigned, whether caused by ROC, or ROC's officers, directors, promoters, sponsors, employees, and agents while the undersigned is participating in an event sponsored, promoted, or directed by ROC. In signing this release, each of the undersigned hereby acknowledges and represents the following:

- 1 That he or she has read the foregoing Release and Waiver of Liability and Indemnity Agreement.
- 2 That he or she shall at all times, while riding in a vehicle participating in an event sponsored, promoted, or directed by the corporation will wear his or her respective seat and shoulder belts.
- 3 That the owner/driver certifies that he/she has inspected this vehicle and same is in good mechanical condition.
- 4 That the owner/driver has or will inform himself/herself about this and subsequent events, the trail(s) involved in this and subsequent events, either by prior participation or by investigation into the event and trail(s).
